



## DELEGATE REGISTRATION IS OPEN: AIT Conference 2024

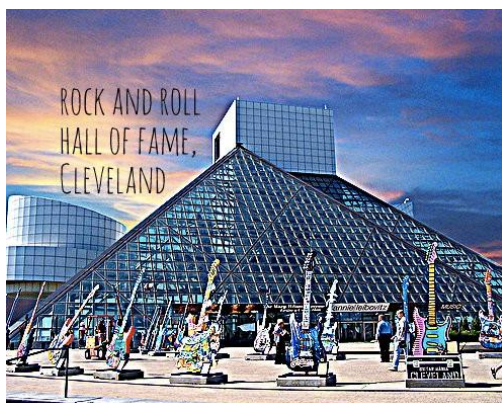
### *“Inhalation Toxicology Rocks”*

The Association of Inhalation Toxicologists (AIT) conference will take place on **Tuesday 17<sup>th</sup> to Thursday 19<sup>th</sup> September 2024** at the Hyatt Regency Hotel at the Arcade in Cleveland, Ohio, USA. There is also an opportunity to visit the Charles River Laboratory site in Ashland, Ohio on **Monday 16<sup>th</sup> September 2024** (for approximately 56 people, full details of the visit to be confirmed).

Attending this conference will commence/renew your AIT membership for the next 3 years and allow free access during your membership to the secure members area of the AIT website to view the recorded webinars and PDF presentations held there from the previous year.

The exciting 2024 scientific agenda includes topics on:

There is usually 1 poster per poster board.

## **AIT Travel Grant for Early Career Inhalation Toxicologists.**

There is one travel grant available worth £500 to help early career scientists\* towards the cost of travel and registration to attend the AIT in-person conference. In addition, if the successful applicant is not already a member of the AIT, they will also receive 3 years free membership of the AIT to enable them to access the previous year's conference documents held in the members area of the AIT website.

Applications are welcome at any time from interested members and non-members of the AIT. The awarding of funding will be at the discretion of the AIT Committee.

This is an excellent opportunity to share your findings with the world's leaders in the Inhalation Toxicology field.

(\* Early career scientist: Researchers who received their terminal education diploma not more than 10 years ago. Researchers working both in academia and industry, as well as PhD, master and bachelor students who are studying/working within a relevant scientific field, or technicians at a recognised institution working towards a professional qualification or gaining more experience within the field of inhalation toxicology are included.

The deadline for submitting an abstract for this years conference is 30<sup>th</sup> June 2024 (12pm GMT).

All applications must be made by email to the AIT at [aitoxicology@gmail.com](mailto:aitoxicology@gmail.com).

Applications will be assessed by the AIT committee on merit. Priority may be given to candidates who have submitted poster abstracts to the meeting.

By applying for the travel grant, all applicants consent to their details being added to the AIT mailing list and will automatically receive information on other events when it becomes available. Details will not be passed on to any other organisation without written permission.
